## 1. Designation and object of SERVICE

### 1.1 Object of Service:

The SERVICE relates to services in the area of „Managed Exchange “.

### 1.2 Purpose, Scope and Type of the Service:

The parties agree on the type and scope as well as the exclusive purposes of the commissioned data processing of the data by the contractor as follows:

With this service, the contractor provides technical and administrative services for the provision and operation of Microsoft Exchange in different variants. In the on-premises variant, incoming and outgoing emails are processed by the contractor. In the hybrid version, emails are processed by Microsoft and possibly by the contractor. When using the optional CodeTwo email signature solution, the emails are also processed by the CodeTwo provider.

Data processing for the purposes of hosting and backup/recovery is covered in the on-premises variant by the underlying Windows Platform Server service.

### 1.3 Type of Data:

Commissioned Data Processing relates to the following types of data:

The personal data processed with Microsoft Exchange depends on the settings and configurations of the organization using Microsoft Exchange. The following personal data can typically be processed:

- Master data (e.g. surname, first name)
- Contact details (e.g. user's e-mail address, telephone numbers, addresses)
- Calendar information (e.g. appointments, meetings)
- Tasks and notes
- Attachments (e.g. images, documents)
- Emails including message text, subject, attachments and metadata such as sender, recipient, date and time
- Address book and distribution list information
- Log files (e.g. server and client connection logs)

The types of data processed in the context of support cannot be precisely defined in advance. The types of data depend on the nature of the client's requests, the types and purposes of the client's systems and on the data provided by the client itself in individual cases.

**Special categories of data<sup>1</sup>:**

#### Microsoft 365

Microsoft 365 (hereafter referred to as M365) is a software as a service (SaaS) package provided by Microsoft on Microsoft Azure cloud infrastructures to the client.

#### MICROSOFT DATA CENTRES AND TENANT

Microsoft follows a regionally-oriented strategy for its data centres.

The country or region selected by the administrator during the initial setup of the services determines the primary location for the client's data in Office 365 ("data at rest").

For German clients, client data from Microsoft Enterprise Services will therefore be stored by default in the Microsoft data centres in the European Union (EU), primarily in Dublin and Amsterdam, until the end of

2019. Since December 2019, Azure data centres in Germany (Frankfurt, Berlin) have also been activated, so that new customers from German companies are now placed there.
